No trespassing laws for Kansas are explained in Chapter 21 Article 37 of Kansas Statutes and Codes. Specifically 21-3721 details that violators will be found guilty of a criminal trespass, a class B nonperson misdemeanor, when entering and remaining without consent on property as defined in this section. Signage for such laws should be posted so that "such premises or property are posted in a manner reasonably likely to come to the attention of intruders."
